

# 会场到达 TRANSPORTATION

#### 北京首都国际机场 (PEK)

- 可乘坐机场快轨或机场大巴北京南站线至三元桥站下车, 出站后乘坐出租车至会场。
- You can take the airport express train or airport bus Beijing South Railway Station Line to the Sanyuanqiao Station, and then take a taxi to the venue.

#### 北京大兴国际机场(PKX)

- 可乘坐北京大兴国际机场线(草桥方向)至草桥站换乘地铁 19 号线(牡丹园方向)至牡丹园站下车,出站乘坐出租车至会场。
- Take the Beijing Daxing International Airport Line (toward Caoqiao) to Caoqiao Station and transfer to Metro Line 19 (toward Mudanyuan) to Mudanyuan Station, and then take a taxi or to the venue.

#### 北京南站 Beijing South Railway Station


